You can take up to two classes at your district school if they allow it as a student at Custom Class. If you are a full time student at another public school, soon you will be able to take 1-6 classes with Custom Class as well.

Custom Class coursework will be accredited by Cognia, the world leader in accreditation used by nearly every school in Utah. That means your student's credits, transcripts, and diplomas will be fully recognized—just like any other Utah public school.

When can I start buying supplies for the new school year?

Families can begin getting reimbursements approved or using our app to directly purchase materials two weeks before the new school year's first term, no later than August 1st for the Fall term. You'll receive clear instructions before your chosen four learning blocks begin.

Can I be reimbursed for things that fall outside my 4 chosen blocks?

Some year-round essentials—like internet or ongoing subscriptions—can still be reimbursed across the full year. Other purchases must support learning within your four chosen terms.

Will internet service be reimbursable?

Yes. Internet service is considered a year-round educational need and can be approved as long as it supports the student's learning plan.

What is a pre-approved plan and what can it include?

A pre-approved plan gives you access to \$2,500 for each child. It's simple, ready-to-use funding for your choice of curriculum, materials, supports, and extracurriculars. It's perfect for families who want to get started with minimal upfront decision-making.

Do items have to match specific subjects like other programs?

Not at Custom Class. Purchases don't have to fit into a narrow set of "subjects" or specific buckets like "technology allowances." As long as the item supports your child's personalized learning plan, it can be reimbursable across a wide range of categories.

Do providers need to be approved?

Providers don't need to go through complicated approval processes. If your child takes piano, robotics, basketball, or tutoring, you can simply submit the receipt or request direct pay through the app—no hoops to jump through. You cannot be reimbursed to pay family members for these services.

Do receipts need to contain only educational items?

Receipts don't have to be perfectly item-specific—you can cross out unrelated items and submit the rest. We just need proof of purchase for the educational components.

How is it funded?

Custom Class is a non-profit who receives funding from the Utah state charter school board and other sources supporting customized education, so enrollment is **tuition-free**. Families receive additional funds to customize their child's learning—covering curriculum, materials, and experiences that fit your goals.
