Custom Class Charter School serves students in **grades K–12**.

Enrollment cap: 2026-27 - 400 students , 2027-28 - 560 students , 2028-29 - 920 students

### Admissions Process

Admissions are conducted on a **lottery-based system** when applications exceed available capacity.

- **Lottery Date:** March 5, 2026

Following the enrollment period, any additional applicants will be placed on a **waitlist** and offered enrollment **as space becomes available**.

### Transfers

Students wishing to transfer **to or from** Custom Class Charter School must submit an application at: <https://customclass.org/apply> **Transfer timelines** and placement are subject to space availability and follow the same timelines as new school applications listed above.

## Fees

Custom Class Charter School **does not charge any enrollment or secondary school fees.**
